From the President

Congratulations

Congratulations on another well-lived and successful year for the Parents of Priests. July 1st marks the beginning of the new fiscal year for our organization. We have had more opportunities to celebrate Mass together and to socialize than has been the case in recent years. Thanks go to our Liturgy committee (Debbie Goodfellow, Lois Butkowski, and Dee Denk) for arranging more “Mass and Doughnut” times and to Mike & Kathleen Cubera for the 2022 summer and the 2023 winter and upcoming summer social events. We should also recognize Fr. Latcovitch for the November event at the seminary and Bishop Malesic for the Palm Sunday event at the Cathedral.

Financially, we are ending the 2023 fiscal year and beginning the 2024 fiscal year in good shape as Mike Cubera’s year end report will show. We set up and contributed to the Parents of Priests Textbook fund which is available to all the seminarians for assistance with philosophy and theology textbooks. We established the Dad’s Wallet Fund in support of the human development pillar of seminary education. Also, we contributed funds to help with tuition for priests to be trained in coaching men and women in discerning the possibility of a religious or priestly vocation.

Congratulations

July 1st marked the transition in leadership of the seminaries. We owe many thanks to Fr. Mark Latcovich for his support and guidance over the last 13 years. We benefited from his advice, and I hope

we were a benefit to the work of the seminaries. Congratulations to him for his many years of strong leadership of the seminaries and another congratulations on his new assignment as pastor of St. Ladislav Parish. I expect we will be contacting him for a Liturgy and Doughnuts Sunday in the not-too-distant future.

We also must congratulate Fr. Andrew Turner on his new assignment as Rector of both Borromeo and St. Mary seminaries. He joins a long line of distinguished priests who have led the seminaries over the past nearly 200 years. We look forward to working with him in support of the seminarians.

By-laws: Proposed Revisions

At the April 23, 2023 Governing Board the Board authorized the President to develop proposed language changes to the Bylaws:

- To allow parents of priests who do not minister in our Diocese to request and be accepted into membership of our organization.
- To eliminate the Ill and Deceased Committee and assign that activity to the Secretary.
- To change the Program Committee to the Social Committee with responsibility for social events other than the “quarterly” Masses.
- To delete the 25 Club Committee and assign leadership responsibilities for fund raising (25 Club) to the Vice President.

The proposed language is included later in this Newsletter/Update for your information and to meet the required distribution of the proposed changes at least three weeks before the next

Governing Board meeting. Underlined text is new language and struck through text is language to be removed.

BYLAWS

ARTICLE I

NAME OF ORGANIZATION

This organization shall be known as PARENTS OF PRIESTS OF THE DIOCESE OF CLEVELAND. The organization shall be under the patronage of THE HOLY FAMILY.

ARTICLE II

NATURE AND PURPOSE

Section 1

The PARENTS OF PRIESTS OF THE DIOCESE OF CLEVELAND shall be, not for profit and operate on a July 1 through June 30 fiscal year.

Section 2 - Purpose

The purpose of the organization is to bring parents together for mutual support and in support of the vocations of their priest-sons. This organization shall also promote the good interests of the Diocesan Seminaries, either directly by its moral and material support, or indirectly by aiding the educational interests of the students. All activities of this organization shall have the approval of the moderator(s).

ARTICLE III

MEMBERSHIP

Membership shall be for parents of diocesan priests but shall include any parent of a priest. Parents of priests of the Diocese of Cleveland are automatically enrolled as members upon their son's ordination. Parents of priests from other dioceses and/or religious orders are accepted as members upon their request to join this organization.

There shall be two classes of membership: Active and Non-Active.

Section 1 Active

ACTIVE MEMBERS pay dues and commit themselves to planning and organizing the activities of Parents of Priests. They participate in various meetings during the year and assume the responsibility of perpetuating the organization.

Section 2 –Non-Active

NON-ACTIVE MEMBERS pay dues and may attend and participate in any of the activities sponsored by the Parents of Priests but would not be responsible for the operation of the organization.

ARTICLE IV

SPIRITUAL BENEFITS

All members shall share in the spiritual benefits enjoyed by this organization. The benefits include, but are not limited to, special Masses for deceased priests and parents of priests, four times a year.

ARTICLE V

MODERATOR(S)

There shall be one or more Moderators of the organization. Such Moderators will be appointed by the Cleveland Diocese and shall serve until their successor(s) be duly certified. The Moderator(s) shall be ex-officio members of all Boards and Committees.

ARTICLE VI

GOVERNING BOARD

The Governing Board shall consist of the Moderator(s), officers, and the Active Members.

ARTICLE VII

OFFICERS AND DUTIES

The elected officers shall be: President; Vice-President; Secretary; and Treasurer. All terms of office shall be for two years. No member shall hold the same office more than three consecutive terms.

Section 1

The PRESIDENT shall preside at all meetings, appoint all committee chairpersons, and be an ex-officio member of all committees except the nominating committee. The President shall be responsible for the administration of this organization with regard to membership and interaction with any and all governmental and/or Diocesan entities, laws, and regulations. The President shall also provide for publishing periodic updates to the membership.

Section 2

The VICE-PRESIDENT shall perform all the duties of the President in case of the absence or unavailability of the President and such other duties as assigned by the President. The Vice-President shall be responsible for the fund-raising activities of this organization, for example, the 25 Club donation appeal.

Section 3

The SECRETARY shall record the proceedings of all meetings. Upon approval, copies of minutes of all meetings shall be presented to the President and Moderator(s). The Secretary shall be responsible for receiving and preserving correspondence received by the organization and for developing and publishing the monthly seminarian prayer calendar and the periodic requests for prayers for members and/or priests of the Cleveland diocese.

Section 4

The TREASURER shall receive and safely keep all monies in proper depositories approved by the organization. The same shall be disbursed under the direction of and to the satisfaction of the Governing Board. It shall be his/her duty to keep an accurate account of the finances of this organization and shall

render an account of its financial condition at all regular meetings of Active members. The report and its underlying documents shall be reviewed by the Ways and Means Committee. Upon approval, copies of such financial report shall be presented to the President & Moderator(s).

ARTICLE VIII

STANDING COMMITTEES

There shall be the following Standing Committees and such other Committees as the organization deems necessary: ~~Membership; "25 Club"; Deceased and Ill Parents of Priests; Program; Social Events,~~ Liturgy; and Ways and Means.

ARTICLE IX

MEETINGS

Regular meetings of the Active members shall be held at least semi-annually. Special meetings of the Active members may be called at the request of the President and/or Moderator(s).

Active members may attend, participate, and vote in the Governing Board meetings either in person or virtually by electronic means.

Meetings of the Standing Committees or Special Committees may be held as requested by the various Committee Chairpersons.

ARTICLE X

ORDER OF BUSINESS AT MEETINGS

Unless otherwise ordered by a majority vote of the members present, the order of business at all regular meetings of the Active members of THE PARENTS OF PRIESTS shall be as follows:

1. Meeting. Called to Order
2. Opening Prayer
3. Roll Call of Members
4. Minutes of Regular and Special
5. Introduction of New Members
6. Communications
7. Report of Standing Committees
8. Report of Treasurer
9. Financial Transactions
10. Report of Special Committees
11. Unfinished Business
12. Election of Officers
13. New Business
14. Installation of Officers
15. Closing Prayer

ARTICLE XI

NOMINATIONS AND ELECTIONS

At the first meeting of the second year of his/her term, the President, shall appoint a nominating committee consisting of Active members. The Chairperson of the committee is to be selected by its members. The nominating committee shall present a slate of nominees at the next regular meeting and election of officers shall immediately follow. Installation shall

take place at the end of the meeting at which they are elected.

All records of this organization are to be presented to the newly installed officers ~~at~~ within 10 days of this meeting.

-Vacancy in any office shall be filled by majority vote of the Governing Board at a regular or special meeting.

ARTICLE XII

REVENUES

Section 1 - Dues

All members shall pay dues. The annual rate of dues shall be established from time to time by the Governing Board. Non-payment of dues shall not affect members' voting rights. This money shall be used to benefit the Parents of Priests activities.

Section 2 - Other Revenue

Revenue derived by this organization shall be used primarily to further vocations to the diocesan priesthood in the Diocese of Cleveland and to help support seminarians as needs arise.

ARTICLE XIII

PARLIAMENTARY AUTHORITY

"Robert's Rules of Order Revised" shall be the parliamentary authority of this organization, except when not consistent with these By-Laws.

ARTICLE XIV

AMENDMENTS

These By-Laws may be amended at any meeting by a two-thirds vote of Active members present and voting, provided the proposed amendment(s) shall have been submitted in writing or by electronic communication means to all voting members three weeks prior to that meeting.
